

On Nandigram

We the undersigned, who have long been associated with the Left movement in the country, feel deeply pained and anguished by the loss of lives and injuries suffered during the police action in Nandigram on March 14. Nobody belonging to the Left would ever justify repressive action against peasants or workers who are the basic classes of the Left. The tragedy at Nandigram on March 14 was an entirely unanticipated, unjustified and unfortunate turn of events, whose exact origin and course should be established through a proper inquiry. The Left Front government meanwhile has announced the removal of the police force from Nandigram, has reiterated its policy that no land will be acquired for industrial purposes without the consent of the peasants and other people concerned, has put on hold all land acquisition, and has put a halt to the construction of special economic zones (SEZs) until the central legislation on SEZs itself, to which the Left has always been opposed, is suitably amended. And the CPI(M), the leading partner of the Left Front, has asked for a judicial inquiry into the tragedy. Under these circumstances, and in view of the fact that the state government has committed itself to recompensing the families of the victims, all efforts must be made so that tension subsides and normalcy returns to the area, allowing the numerous refugees, who have been driven out from there and living in makeshift camps, to return home. We appeal to all concerned not to let the wounds of Nandigram become festering sores.

Neglect of Children under Six

The following is an open letter to prime minister Manmohan Singh:

We are writing to express our deep concern about the neglect of children under six in the Union Budget 2007-08.

You may remember meeting some of us on December 19 last year (just after "Bal Adhikar Samvad"), when we discussed the FOCUS Report, the rights of children under six, and the recent Supreme Court judgment on Integrated Child Development Services (ICDS). At that time you had assured us that the UPA government was committed to the universalisation of ICDS, as stated in the Common Minimum Programme (CMP), and also to the implementation of the Supreme Court judgment. We are, therefore, startled and dismayed that this commitment is not reflected at all in the Union Budget 2007-08. The allocation for ICDS (Rs 4,761 crore) has barely increased in real terms, and is virtually unchanged as a proportion of GDP.

It is a mystery to us how the CMP commitment and Supreme Court judgment can possibly be implemented within such meagre budget allocations. The Supreme Court judgment requires an increase in the number of anganwadis from the present 9.4 lakhs to 14 lakhs at the very least by December 2008. Higher allocations are also required to enhance the quality of ICDS services. Based on fairly conservative calculations of the requirements of "universalisation with quality", the National Advisory Council had recommended (in November 2004) an allocation of at least Rs 9,600 crore for ICDS in 2007-08. This figure needs upward revision in the light of the Supreme Court judgment, yet the actual provision in the Union Budget 2007-08 is not even half of this conservative estimate.

As per this budget, the government of India will be spending less than Rs 5,000 crore this year on children under six, who represent more than 15 per cent of India's population. This

compares with Rs 96,000 crore to be spent on "defence". This is a staggering and unacceptable imbalance in budget priorities. The contrast is all the more shocking at a time of growing evidence (particularly from the National Family Health Survey) that there has been no substantial improvement in infant and young child nutrition, including optimal breastfeeding practices, during the last eight years, in spite of runaway economic growth.

We urge you to intervene and ensure a fairer deal for children in the Union Budget 2007-08 as well as in the Eleventh Plan. We also take this opportunity to reiterate our appeal for

more active political leadership on children's issues, including the universalisation of ICDS.

Notes for Contributors

Here are some guidelines for authors who wish to make submissions to the journal.

Special Articles

EPW welcomes original research papers in any of the social sciences.

- ★ **Articles must be no more than 8,000 words, including notes, references and tables. Longer articles will not be processed.**
- ★ **Contributions should be sent in a hard copy format accompanied by a floppy/CD version. A soft copy can also be sent by email. Hard and soft copy versions of articles are essential for processing.**
- ★ **Special articles should be accompanied by an abstract of a maximum of 150-200 words.**
- ★ Papers should not have been simultaneously submitted for publication to another journal or newspaper. If the paper has appeared earlier in a different version, we would appreciate a copy of this along with the submitted paper.
- ★ Graphs and charts prepared in MS Office (Word/Excel) or equivalent software are preferable to material prepared in jpeg or other formats.
- ★ Every effort is taken to complete early processing of the papers we receive. Since we receive more than 35 articles every week and adequate time has to be provided for internal reading and external refereeing. **It can take up to four months for a final decision on whether the paper is accepted for publication.**
- ★ **Articles accepted for publication can**

take up to six to eight months from the date of acceptance to appear in the EPW. Every effort will, however, be made to ensure early publication. Papers with immediate relevance for policy would be considered for early publication. Please note that this is a matter of editorial judgment.

Commentaries

EPW invites short contributions to the 'Commentary' section on topical social, economic and political developments. These should ideally be between 1,000 and 2,500 words and exclusive to the EPW. Short contributions may be sent by email.

Book Reviews

EPW sends out books for review. It does not normally accept unsolicited reviews. However, all reviews that are received are read with interest and where a book has not been sent out for review, the unsolicited review is on occasion considered for publication.

Letters

Readers of EPW are encouraged to send comments and suggestions (300-400 words) on published articles to the Letters column. All letters should have the writer's full name and postal address.

Discussion

EPW encourages researchers to comment on Special Articles. Submissions should be 1,000 to 2,000 words.

General Guidelines

- ★ **Writers are requested to provide full details for correspondence: postal**

address, day-time phone numbers and email address.

(The email address of writers in the Special Article, Commentary and Discussion sections will be published at the end of the article.)

- ★ Authors are requested to prepare their soft copy versions in text formats. PDF versions are not accepted by the EPW. Authors are encouraged to use UK English spellings (Writers using MS Word or similar software could change the appropriate settings in the Language menu of the application).
- ★ Contributors are requested to send articles that are complete in all respects, including references, as this facilitates quicker processing.
- ★ When there are major developments in the field of study after the first submission, authors can send a revised version. **EPW requests writers not to send revised versions based on stylistic changes/additions, deletions of references, minor changes, etc, as this poses challenges in processing.**
- ★ All submissions will be acknowledged immediately on receipt with a reference number. Quoting the reference number in inquiries will help.
- ★ EPW posts all published articles on its web site and may reproduce them on CDs.
